- 3. <u>BYLAWS</u>: RESOLVED, that the Bylaws attached hereto as Exhibit "B" have been duly reviewed in their entirety by the Corporation's shareholder who, by proper action, adopted them as the Official Bylaws of the Corporation.
- 4. <u>DIRECTORS</u>: RESOLVED, that the following individual be, and is hereby, elected by the sole shareholder as the director of the Corporation to serve until his successors are duly elected, qualified and seated:

- 5. <u>REGISTERED OFFICE</u>: RESOLVED, that the registered office and registered agent of the Corporation, initially fixed by the terms of the Corporation's Articles of Incorporation, be retained pending further action by the Director.
- 6. <u>AUTHORITY TO DO BUSINESS</u>: RÉSOLVED, that for the purpose of authorizing the Corporation to do business in any state, territory or dependency of the United States, or any foreign country in which it is necessary or expedient for the Corporation to transact business, the proper officers of this Corporation are hereby authorized to appoint and substitute all necessary agents or attorneys for service of process, to designate and change location of all necessary statutory offices and, under the corporate seal, to make and file all necessary certificates, reports, powers of attorney and other instruments as may be required by the laws of such state, territory, dependency or country, to authorize the Corporation to transact business therein and whenever it is expedient for the Corporation to cease doing business therein and withdraw therefrom, to revoke any appointment or surrender any authority as may be

- 7. <u>PAYMENT OF FEES</u>: RESOLVED, that the appropriate officers of the Corporation be and are hereby authorized to pay all fees and expenses incident to and necessary for the organization of the Corporation.
- 8. <u>STOCK CERTIFICATES</u>: RESOLVED, that the form of stock certificate attached hereto as Exhibit "C" is approved and adopted.
- 9. <u>DEPOSITORY</u>: RESOLVED, that the officers of the Corporation, acting singly, be and are hereby authorized and directed to establish banking and checking accounts on behalf of the Corporation at such banks as the officers of the Corporation deem necessary for the operation of the Corporation, and the printed resolutions supplied by such bank (if any) are deemed resolutions of the Corporation duly adopted by the Board of Director as if each such resolution were set forth herein.
